All MBA students are categorized as either Level I or Level II. **Full-time or Co-op** - You are Level I for the first two academic terms. You are Level II upon commencement of your third academic term. If you are an Accelerated student, you are in Level II. **Part-time** - you are in Level II upon completion of your seventh 600-level course (including transfer credits and waivers).

* New Health and Dental Plans (covering September to August): All Co-op and Full-time MBA students are required to pay the new Health and Dental Insurance fees. The non-refundable administrative fee of \$30.00 is required to be paid whether a student opts out of either the Health or Dental Insurance Plan or both. The costs of the plans are paid per academic year. All full-time and co-op students pay for the plans in September 2017.

** All Visa students must enroll in the University Health Insurance Plan (UHIP). Please refer to the International Students Services website at <http://oisa.mcmaster.ca>

Any academic course taken off sequence is considered a part-time course and students need to pay extra for that course in the term in which it is taken.

Part Time Students - a load of 1 or 2 courses each term is recommended. If a part-time student wishes to enroll in 3 courses, documented employer permission is required. Please schedule an appointment (phone or in person) with an MBA Academic Advisor in advance. Although McMaster University deems 3 courses per term as full-time studies, part-time MBA students will only pay part-time ancillary fees.
