

THIS AGREEMENT made this 14 day of February, 1986

BETWEEN : McMASTER STUDENTS UNION INCORPORATED  
(hereinafter referred to as MSU)

AND : McMASTER ASSOCIATION OF PART-TIME STUDENTS  
(hereinafter referred to as MAPS)

WHEREAS the MSU is the organization officially recognized by McMaster University as representative of full-time undergraduate students;

AND WHEREAS MAPS is the organization officially recognized by McMaster University as representative of part-time undergraduate students;

AND WHEREAS an agreement is required to define the membership of MSU and MAPS for the purposes of collecting fees;

NOW THEREFORE the MSU and MAPS hereto covenant and agree to replace the MEMORANDUM OF AGREEMENT of August 17, 1979 with the following:

DEFINITION OF A PART-TIME STUDENT

1. For purposes of this agreement a part-time student is defined as a student who is registered in less than eighteen (18) units of undergraduate degree courses or programs in any one academic session, or is enrolled in a certificate course/courses at this university. A part-time student is a member of the MAPS organization and fees will be collected for that organization.

DEFINITION OF A FULL-TIME STUDENT

2. Every undergraduate student taking eighteen (18) units or more during the winter session (i.e. in courses beginning in September, January or February) is a member of the MSU until the beginning of the next academic year, and fees will be collected for that organization.

ALLOCATION OF SUMMER FEES

3. Fees paid by students enrolled in the summer session (i.e. in courses beginning in April, May or June) will be collected and turned over to MAPS. However, if during the immediately previous winter session the student was a member of the MSU, the student has the option of transferring his/her fees through the appropriate channels to the MSU. One such channel shall be the signing of transfer forms by individual students. The MSU agrees to notify MAPS by July 31st of each year of those students wishing to transfer membership and fees to the MSU. All fees will be transferred within one month of notification.

SETTING OF FEES

4. It is the responsibility of each student organization to recommend the amount of its membership fees to the Board of Governors no later than the end of February for implementation in September.

ENABLING CLAUSE

5. This AGREEMENT will take effect May 1, 1986 and will continue in force until revised by the two organizations concerned (MAPS and MSU).

THIS AGREEMENT is authorized by the recognized officials of MSU and MAPS, with their signatures duly witnessed.
